Artwork

- All works must be an original creation by the artist. Each artist, by entering ABS' #Time2Sketch, confirms that they hold all intellectual property rights in the work.
- By submitting your work to #Time2Sketch you are agreeing (if selected) that your sketch will appear in our colouring book which will be sold to benefit ABS. You are also agreeing for ABS to use your sketch in any promotional materials including social media, website and other.
- Please ensure images submitted are good quality (usually 300dpi is best). Please remember winning and longlisted entries will be included in a colouring book with the intention of being coloured in.
- Artwork must be in black and white, with no colour due to the potential inclusion in the ABS colouring book.
- Please submit your image files in the format: YOURINITIALS_TITLEOFWORK.JPG
- Do NOT submit work that is transphobic, racist, pornographic, paedophilic, anti-LGBTQUIA+, ageist or could be deemed offensive or as a hate crime against a minority culture and or group.
- Sketches may be done on physical paper or digitally.

Submission

- You may only submit 1 sketch for consideration. Please do not enter more than one.
- To be considered and entered into the competition all artworks must be sent to the communications@absnet.org.uk email address before 13:30 on Thursday 8th September.
- By submitting artwork to communications@absnet.org.uk you agree that the submission is your own work and give the Architects Benevolent Society permission the free use to print, publish and share your submission.
- Tickets may be purchased on a group or individual basis, but submission must be by individual only.

Judging

- The judges' decision is final and binding; no correspondence can be entered into.
- 3 winners will be selected and informed on the Monday 19th September 2022. If we are unable to contact any of the winners within 1 week, we reserve the right to select a new winner.
- A further 20+ longlisted sketches will be included in the 2022 ABS #Time2Sketch colouring book.

Entry

- Entry fee: If your entry is accepted your fee is not refundable

Data protection
