- All works must be an original creation by the artist. By entering ABS' #Time2Sketch, each artist confirms that they hold all intellectual property rights in the work.
- By submitting your work to #Time2Sketch you are agreeing (if selected) that your artwork will appear in the online gallery with a credit. You are also agreeing for ABS to use your artwork in ABS promotional materials including social channels and our website.
- Please ensure images submitted are good quality (usually 300dpi is best).
- Artwork can be colour or black & white.
- Please submit your image files in the format: YOURINITIALS_TITLEOFWORK.JPG
- Do NOT submit work that could be deemed offensive.
- Sketches may be done on physical paper or digitally.

Submission

- You may only submit one sketch for consideration.
- To be considered and entered into the competition all artworks must be sent to connect@absnet.org.uk before 13:30 on Wednesday 10th December 2025.
- Tickets may be purchased on a group or individual basis, but submission must be by individual only.
- Submission does not guarantee inclusion in the online gallery.

Judging

- The judges' decision is final and binding; no correspondence will be entered into.
- Three winners will be selected and informed on the Friday 19th December 2025.
- A further 20+ longlisted sketches will be included in the 2025 ABS #Time2Sketch gallery.
